VIRTUAL MEETING ACCESS AND PARTICIPATION INSTRUCTIONS

If you wish to participate during the public comment portion of an agenda item, then you must: Join the meeting using Microsoft Teams: **Meeting ID: 263 719 966 184 25, passcode: ak38PF3f**

- When the Public Comment portion of a case you wish to speak on is opened to the public, you as an attendee must then click the “raise hand” button in order to indicate to the Board Chair or Secretary that you wish to speak.
- After clicking “raise hand” listen for your name, phone number or other ID, given to you during login. Permission to speak will then be granted to you.
